Exhibit Management

Presentation

Transcript

- Easily import pdf, text or MS Word transcript files.
- Classify, annotate and cross reference transcript files with exhibits, discovered documents and other artefacts.
- Automatically insert hyperlinks on exhibit numbers appearing in transcript documents.

Witness Briefs

- Collate all the documents relevant to a witness in a document set for ease of reference during pre-trial interviews or the hearing.
- Produce spreadsheet reports for witnesses with hyperlinks to pdf documents.
- Automatically hyperlink exhibit references within witness statements or transcripts using EDT's document hyperlinking feature.

Remote Access

- Using EDT's hosting capabilities, any documents can be accessible immediately via the Internet to those with permission to access them.
- Lawyers working remotely can virtually access the courtroom proceedings instantly from their offices.
